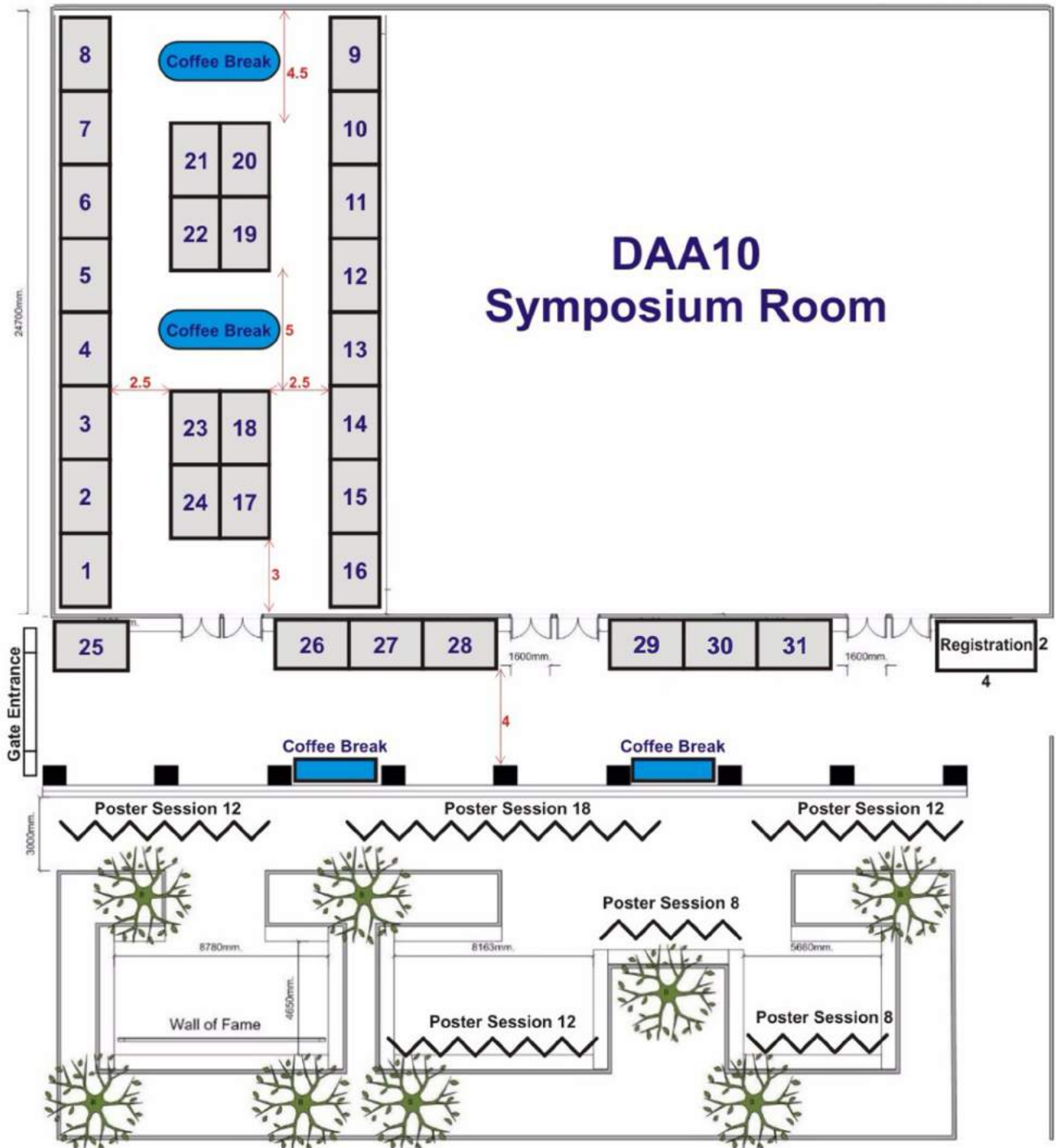


# Floor Plan DAA10
